## What is the product?

Type: This Product is a common fund qualifying as an 'other fund for traditional investments' in accordance with the Swiss Federal Act on Collective Investment Schemes.

**Objectives:** The investment objective of Baloise Fund Invest (CH)- Aktien Schweiz is principally to achieve an appropriate return through direct and indirect investments in a portfolio of equities in Swiss companies. In terms of stock and sector weightings, the asset manager's focus is on the Swiss equity market. Individual stocks are selected at the manager's own discretion following a quantitative and qualitative assessment. The portfolio is broadly diversified. The long-term aim is to generate higher returns amid lower volatility compared with a traditional equity portfolio. The fund management company does not guarantee that this investment objective will be met. This Unit Class does not make distributions.

Intended Retail Investor: This Product is intended for retail investors as well as institutional investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

Term: This Product has no maturity date. The Subfund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge, or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

## What are the risks and what could I get in return?

# (A) Summary Risk Indicator



The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. #### Cost over time
