What is the product?

Type: This Product is a common fund qualifying as an 'other fund for traditional investments' in accordance with the Swiss Federal Act on Collective Investment Schemes.


Objectives: The investment objective of Baloise Fund Invest (CH) – Global Bonds CHF Optimized is principally to achieve an appropriate return through direct and indirect investments in a portfolio of bonds worldwide, denominated in any currency. By means of the currency allocation, the asset manager seeks to optimize the investments in terms of the Swiss franc, as reference currency. This optimization takes place at the discretion of the asset manager on the basis of a systematic investment approach. The currency specified in the name of the subfund is typically not the subfund's investment currency. Units are issued and redeemed in Swiss francs (CHF), as reference currency, and are currency-hedged, i.e. the risk exposure regarding investment currencies is at least 90% hedged against the CHF. The fund management company does not guarantee that this investment objective will be met. This Unit Class does not make distributions.

Intended Retail Investor: This Product is intended for retail investors as well as institutional investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

Term: This Product has no maturity date. The Subfund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge, or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 2 out of 7, which is a low risk class and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, and legal risks that are not included in the Summary Risk Indicator. Cost over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing, and incidental costs. They include potential early exit penalties. The figures assume you invest CHF 10,000. The figures are estimates and may change in the future.
