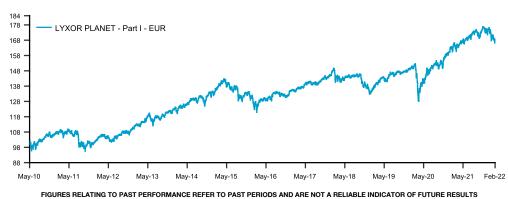

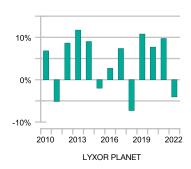

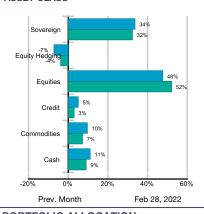
INVESTMENT OBJECTIVE
