

Investment Case

One of the primary reasons for launching the Fund is our belief that the Renminbi (RMB) is currently undervalued in 'Purchasing Power Parity' terms, both on absolute measures and relative to China's net foreign assets. We believe the Renminbi could appreciate by an average of 1.5% to 2.5% a year, on average, over the next ten years against its tradeweighted basket of currencies (IMF WEO, Guinness estimates).

Process

The Fund will invest in government and quasi-sovereign bonds in the onshore China bond market, as well as supranational and high-grade corporate credit in the offshore bond market.

Portfolio

A high conviction, short duration strategy, with a targeted duration of three years or less
