Purpose

What is this product?

Type:

This product is a UCITS Fund.

Objectives:

The Fund aims to provide an attractive level of total return, income plus capital appreciation, primarily by seeking exposure to a broad range of commodities across various commodities groups globally.

There can be no guarantee that the Fund will ultimately achieve its investment objective. The Fund seeks to obtain this exposure through a blend of investments in commodity-related financial derivative instruments, limited to total return swaps which provide the Fund with exposure to a range of UCITS eligible financial indices comprised of commodity futures; direct investment in the equities and equity-related securities namely, common and preferred stock, American depositary receipts, global depositary receipts of commodity-related companies. The Fund may also invest in units or shares of collective investment schemes, including exchange traded funds and other sub-funds of the umbrella, where such investment provides commodity exposure consistent with the investment policy of the Fund. The Fund will also invest in fixed income instruments, including cash and cash equivalent instruments to manage the collateral of the swap exposures. The balance at any time between the Fund's investment in commodity-related swaps and in other commodity-related investments, will be based on fundamental and quantitative research and the risk-reward of owning commodity related derivatives over a direct holding in commodity-related equities or in other commodity-related investments or vice versa.

The Fund does not apply the ESG Policy and deems Sustainability Risks not to be relevant to the Fund strategy.

As your shares are in US Dollars and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Any income earned on investments will be added to the value of investors' shares.

What are the risks and what could I get in return? Risk Indicator

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below US\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between subfunds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.

Intended retail investor:

This fund may be compatible with the needs of investors seeking a fund to deliver capital growth with an investment horizon of 3 years or more, as part of a diversified portfolio of investments.

This is a medium to high risk product and investors should consider this when deciding the mix of portfolio investments.

Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this product or to construct a diversified portfolio should seek professional investment advice.

The product is unlikely to be compatible with the needs of those investors seeking a single investment, or who require preservation of capital or to achieve a specified return by a particular date.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the ability for you to receive a positive return on your investment.

This product also carries market risk, operational risk, counterparty risk, currency risk, and other risks. Please refer to the "Risk Factor" section of the Prospectus. This product does not include any protection from future market performance so you could lose some or all of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
