## What is this product?

<b>Type</b>	The Fund is an Undertaking for Collective Investment in Transferable Securities (UCITS) established as a sub-fund of Kepler Liquid Strategies ICAV, an open-ended Irish collective asset-management vehicle with segregated liability between sub-funds, established under the laws of Ireland and authorised by the Central Bank of Ireland under the UCITS Regulations.
<b>Term</b>	The Fund has no minimum fixed term. Termination of the Fund is only possible in those cases expressly provided for in the Prospectus or Supplement of the Fund.
<b>Objectives</b>	<p>The Fund is a market neutral equity long/short fund. The Fund will seek to achieve its investment objective by investing up to 100% of its assets directly and/or indirectly through financial derivative instruments ("FDI") primarily in publicly-traded global equity securities. The Fund seeks to achieve attractive rates of return by investing primarily in equity securities of companies that are well positioned in their industries with superior products and technologies, while selling short those companies that have weaker competitive positions. While the Fund invests primarily in global equity securities, as part of the overall risk management and liquidity management of the Fund, the Fund's investments may also include long or short positions in U.S. or non-U.S. publicly traded or privately issued equity and debt instruments as more particularly detailed in the Supplement. The Fund may also invest in initial public offerings of those equity securities that are consistent with the Fund's strategies, in accordance with the rules and regulations pertaining to such investments, including the Consolidated Rulebook of the Financial Industry Regulatory Authority, Inc. (the FINRA Rules). The strategy is fundamentals-based in that the Sub-Investment Manager seeks to make investments based on researching the fundamentals of individual companies in the context of their individual performance and management, their respective industry sectors, their competitive environment, and the economy or markets at large. This results in the Sub-Investment Manager using a proprietary bottom-up research approach and financial analysis to select investments for the Fund. The Fund invests in companies of all sizes, although it focuses primarily on mid-capitalisation companies.</p> <p>No more than 10% of the net asset value of the Fund may be invested in other collective investment schemes.</p> <p>The Fund is actively managed without reference to a benchmark.</p> <p>The Fund seeks to promote environmental and social characteristics within the meaning of Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector (the "SFDR"). The Fund also incorporates environmental, social and governance ("ESG") criteria for the assessment and selection of investments.</p>

### Summary Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. ## How long should I hold it and can I take my money out early?

The Fund has no required minimum holding period but has a recommended holding period of 5 years and is designed for medium-long term investment. You can redeem your investment at any time during the recommended holding period, or hold the investment longer. You may sell your shares or buy more shares in the Fund each business day as defined in the Funds Supplement. When you sell shares, a charge (anti-dilution levy) may be payable to cover the costs incurred by the Fund in selling investments for the Fund. No other fees or penalties will be charged by the Fund for any such transaction, however an execution fee might be chargeable by your broker if applicable.

By selling your shares in the Fund earlier than the recommended holding period, you may receive back less than you would have received if you had kept the shares for the recommended holding period. In volatile or unusual market conditions, or in the event of technical faults/disruptions, the purchase and/or sale of the Fund can be temporarily hindered and/or suspended and may not be possible at all.
