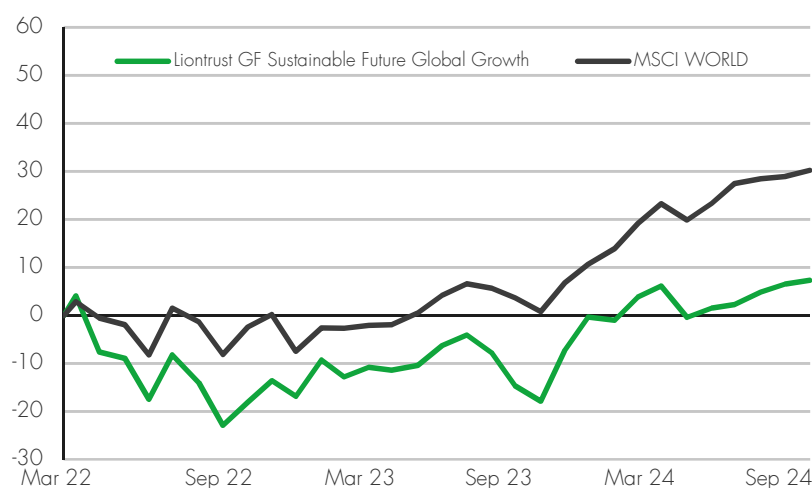


## Our experienced fund management team
