The Fund seeks to add value through active management by identifying and capturing relative value opportunities within the US high yield bond market with an active, risk managed approach using fundamental credit analysis. The Fund incorporates environmental, social and governance ("ESG") factors into its investment process and promotes certain sustainability characteristics. **PGIM Fixed Income** has determined that the Fund qualifies as a Light Green Fund, which is a fund that seeks to comply with the principles of Article 8 of the SFDR.
