Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

The Central Bank of Ireland (the "Central Bank") is responsible for supervising NBAMIL, which is part of the Neuberger Berman Group, in relation to this KID.

The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended) and has been registered for sale in other EEA Member States. What is this product?

Type:

This product is a UCITS Fund.

Objectives:

The Fund aims to increase the value of your shares through a combination of growth and income by investing in a concentrated portfolio principally in securities issued by Real Estate Investment Trusts ("REITs"). The Fund can invest in:

- Equity REITs which invest the majority of their assets in property and derive their income from rents and capital gains from appreciation realised through property sales
- Mortgage REITs which invest the majority of their assets in real estate mortgages and derive their income mainly from interest payments
- Hybrid REITs which combine the characteristics of both equity and mortgage REITs
- Debt securities

The Fund may invest in companies of any market capitalisation but shall typically invest in REITs that have market capitalisation greater than USD \$300m at the time of purchase. REITs are companies or trusts that invest mainly in income producing real estate. They may invest broadly or specialise in a particular sector such as offices, industrial buildings or shopping centres. The Fund does not invest directly in real estate.

The Fund may invest up to 20% of the Portfolio's Net Asset Value (NAV) in debt securities.

Illiquid securities are securities that cannot be expected to be sold within 7 days in the ordinary course of business for approximately the amount at which the Portfolio has valued the securities. These may include unlisted or other restricted securities, which at all times will be in accordance with the requirements of the Central Bank of Ireland.

The Fund promotes environmental and social characteristics pursuant to Article 8 of SFDR.

As your shares are in Australian Dollars and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Income will be rolled up into the value of your investment.

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below US\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between subfunds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.



What are the risks and what could I get in return?

Risk Indicator

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the ability for you to receive a positive return on your investment.

How long should I hold it and can I take money out early?
