The Benchmark currently includes securities of issuers located in developed market countries with each constituent being weighted based on the current amount outstanding on the security, subject to the total allocation to any one issuer being capped at 2% of the Benchmark, unless the Benchmark contains less than 50 issuers, in which case, the Benchmark will be equally weighted between all issuers contained within the Benchmark.
