Fund Description and Risks


Monthly commentary

February's macro-economic news split neatly in two. In the first half of the month, the latest US CPI print and reports from the ECB and BoE gave investors further confirmation that central bankers may no longer see inflation as transitory and that rate rises might occur both sooner than anticipated, and at a faster rate. The second half of February was dominated by the build-up of Russian forces on the Ukrainian border, and the subsequent invasion. All this macro news had significant effects on financial markets. Overall, the Fund returned down with gains from the inflation bucket and losses in bonds, credit, and stock indices. The inflationary backdrop coupled with warfare between Russia and Ukraine, countries known for their energy exports, drove commodity prices almost uniformly higher. Inflation linked bonds benefitted as well as the US 5-year breakeven inflation rate pushed above 3%. Bonds detracted, with losses mostly on the back end of the curve. Longer-dated German and Italian bonds suffered most, as markets continued pricing in a higher inflation rate lasting longer. Shorter-dated bonds finished broadly flat. Stock positions struggled as well, with European stocks taking the brunt of the fallout from the hostilities in Ukraine. Small gains were realized in the Australian SPI 200. Credit spreads widened and all credit index positions finished in the red, with the strongest losses for high yield indices in the US and Europe. While the portfolio exposure finished slightly higher compared to the end of January, the overlay activity during the month was substantial. The volatility overlay picked up an increase in volatility across asset classes and at portfolio level and cut the exposure accordingly. The largest volatility de-gear signals were noted across credit and inflation sensitive assets. The momentum overlay was active as well, predominantly in bonds and credit, cutting the exposure by up to 40%. However, the majority of the portfolio exposure was driven by the correlation overlay which held on to its de-gear signal throughout most of the month and then regressed as soon as the equity-bond correlation started to normalize, allowing the Fund to benefit from the flight to safety in its bond holdings during the last week of the month.



Performance chart 12 December 2014 to 28 February 2022*



Sector Exposure 7






