This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Neuberger Berman Asset Management Ireland Limited ("NBAMIL"), the manufacturer of the Key Information Document ("KID")

The Central Bank of Ireland (the "Central Bank") is responsible for supervising NBAMIL, which is part of the Neuberger Berman Group, in relation to this KID.

The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended) and has been registered for sale in other EEA Member States. What is this product?

Type:

This product is a UCITS Fund.

Objectives:

The Fund aims to achieve a target average return of 1-2% over the JPMorgan JESG CEMBI Broad Diversified Index ("Benchmark") before fees over a market cycle (typically 3 years) by investing primarily in corporate debt issued in emerging (less developed) market countries. There can be no guarantee that the Fund will ultimately achieve its investment objective. The Fund is managed with a disciplined approach which begins with analysis of the market environment and the global economy then with identifying asset classes with attractive valuations and liquidity. Investment selection is the result of fundamental analysis in an effort to identify issuers that are believed to be undervalued and have strong credit quality. Investments will primarily be in hard currency (defined as USD, EUR, GBP, JPY, CHF) but up to one third of the Fund may be denominated in local currencies. Investments will primarily be in corporate bonds but up to one third of the Fund may be in government bonds. Investments may be made in investment grade, high yield or unrated debt securities. Investment grade securities are highly rated securities, generally those rated Baa3, BBB or above by one or more recognised rating agencies. High yield bonds have a lower credit rating because they carry a higher risk of not being paid back and typically offer a higher income to make them attractive to investors.

The Fund is actively managed and does not intend to track the Benchmark, which is used for performance comparison purposes.

The Fund promotes environmental and social characteristics pursuant to Article 8 of the SFDR.

As your shares are in Swedish Kronor and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Income will be rolled up into the value of your investment.

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below US\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.

Intended retail investor:

This fund may be compatible with the needs of investors seeking a fund to deliver income or capital growth with an investment horizon of 3 years or more, as part of a diversified portfolio of investments.

This is a medium to high risk product and investors should consider this when deciding the mix of portfolio investments.

The product is unlikely to be compatible with the needs of those investors seeking a single investment, or who require preservation of capital or to achieve a specified return by a particular date.

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level and poor market conditions are very unlikely to impact the value of your investment. This product also carries market risk, operational risk, counterparty risk, currency risk, and other risks. Please refer to the "Risk Factor" section of the Prospectus. This product does not include any protection from future market performance so you could lose some or all of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if NBAMIL is unable to pay out?

What are the costs?

We have assumed, in the first year you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the fund performs as shown in the moderate scenario and the investment is SEK 10,000.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

The Fund is designed to be held over the medium to long term and we recommend that you hold this investment for at least 4 years. Shares in the Fund can be bought or sold on a daily basis (save on certain bank holidays or public holidays and subject to certain restrictions described in the Prospectus).
