# Purpose

Neuberger Berman Asset Management Ireland Limited ("**NBAMIL**"), the manufacturer of the Key Information Document ("**KID**") The Central Bank of Ireland (the "Central Bank") is responsible for supervising NBAMIL, which is part of the Neuberger Berman Group, in relation to this KID.

The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended) and has been registered for sale in other EEA Member States. # What is this product?

### Type:

This product is a UCITS Fund.

### **Objectives:**

The Fund aims to increase the value of your shares over the long-term through investment in businesses that are connected with emerging (less developed) market countries and economies.

The Fund invests in a mixture of companies of different sizes, from different industries and does not focus on any specific country.

Investment selection is the result of fundamental research and analysis in an effort to identify companies that are believed to be undervalued, have strong corporate governance, are well managed and are financially strong. The investments are mainly in publicly traded shares or related instruments.

Investments may be sold when they reach a target price, when the company's business fails to perform or when other opportunities are more attractive. The Fund may not invest greater than 20% of its Net Asset Value ("NAV") in non-emerging market countries securities. The Fund may invest up to 10% of its NAV in China A-shares or in China B shares.

China A-shares: Shares in mainland China-based companies that trade on Chinese stock exchanges such as the Shanghai Stock Exchange and the Shenzhen Stock Exchange quoted in Chinese renminbi. A-shares are generally available for purchase by mainland citizens in China; foreign investment in A-shares is subject to significant regulatory restrictions.


China B-shares: Shares in mainland China-based companies that trade on Chinese stock exchanges such as the Shanghai Stock Exchange and the Shenzhen Stock Exchange quoted in a foreign currency such as US dollar. Bshares are more widely available for purchase by foreign investors.

The Fund promotes environmental and social characteristics pursuant to Article 8 of the SFDR.

As your shares are in Australian Dollars and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Income will be rolled up into the value of your investment.

# What are the risks and what could I get in return? Risk Indicator

### Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below US\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between subfunds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.

### Intended retail investor:

This fund may be compatible with the needs of investors seeking a fund to deliver capital growth with an investment horizon of 3 years or more, as part of a diversified portfolio of investments. This is a medium to high risk product and investors should consider this when deciding the mix of portfolio investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this product or to construct a diversified portfolio should seek professional investment advice. The product is unlikely to be compatible with the needs of those investors seeking a single investment, or who require preservation of capital or to achieve a specified return by a particular date.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the ability for you to receive a positive return on your investment.

This product also carries market risk, operational risk, counterparty risk, currency risk, and other risks. Please refer to the "Risk Factor" section of the Prospectus. This product does not include any protection from future market performance so you could lose some or all of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

#### **Performance scenarios**

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed, in the first year you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the fund performs as shown in the moderate scenario and the investment is AUD 10,000.
