Preserve value creation and establish a forward-looking construct for managing risk.

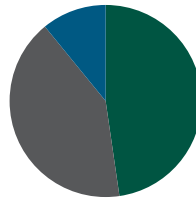

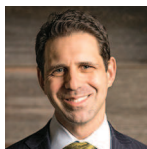
