



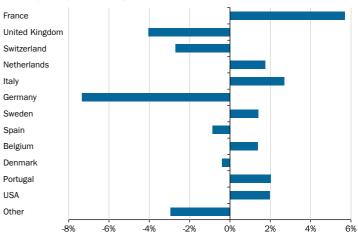

Subscription / Redemption
