## What is the product?

**Type:** This Product is a share in a Sub-fund of the Umbrella qualifying as an alternative investment fund under the law of 12 July 2013 on alternative investment fund managers and the AIFMD regulation.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Bond Sub-fund is actively managed aiming to achieve capital growth by direct investments in global debt instruments of different currency, such as bonds, notes or fixed-interest and floating-rate securities of public, private and semi-private companies from insurance and reinsurance sectors that are exchange-traded. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund might hold up to 20% of its net assets in debt instruments below investment grade BBB- (S&P) or Baa3 (Moody's). The Sub-fund may invest in Additional Tier 1 (AT1) and Restricted Tier 1 (RT1) capital securities. These securities are typically issued by financial institutions to meet regulatory capital requirements and may have loss-absorbing features that can be triggered in certain circumstances, such as the issuer's financial distress. In order to reach its objective, the Sub-fund can use derivative instruments to protect against movements in currencies and security prices and for efficient portfolio management. This Share Class does not make regular distributions.

**Intended Retail Investor:** This Product is intended for professional and institutional investors, as well as sophisticated retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

## What are the risks and what could I get in return?

### (A) Summary Risk Indicator
