## Portfolio Commentary

The ICE BofA Non-Financial Developed Markets High Yield Constrained Index (USD Hedged) was up 0.8% for the month, as compared to U.S. investment grade corporate bonds (up 1.9%), the 10-year Treasury (up 3.0%) and the S&P 500 (down 1.3%).

BB and B-rated bonds performed the best during the month, outperforming CCC-rated bonds by roughly 60 bps.

At month end, the Global High Yield Bond portfolio remained broadly diversified. Roughly 70% of the global portfolio was allocated to North American high yield bonds, with the balance to European high yield. In terms of industry exposure, Support-Services (5.9%) and Cable & Satellite TV (5.8%) represented the two largest sectors in the portfolio.

The portfolio benefited from our overweighting of, and credit selection in the Real Estate Dev & Mgt sector, while our holdings in the Building Materials sector detracted from relative performance.
