#### und management comment

In February, global equities declined 0.7% due to concerns over US trade policies and economic data, while emerging markets managed to end the month slightly higher, led by a solid gain in Chinese equities. The US Federal Reserve maintained its restrictive monetary policy, while the European Central Bank is expected to continue cutting policy rates. Bond markets saw a fall in US yields due to growth concerns, while currency markets reflected investors' uncertainties about the economic scenario, with the US dollar experiencing a sharp rise at the end of the month. The strategy recorded a positive performance driven by European and Chinese equities, although US equities weighed negatively following correction driven by the tech sector. Bonds were slightly penalized by US short duration but this was compensated by the long position on commodities. Positions are rather stable. vet with some deleverace on equities through US and Japan.

# **Investment Objective**

The THEAM Quant - Multi Asset Diversified Defensive Fund seeks to increase the value of its assets over the medium term by being exposed to a diversified portfolio, the components of which are chosen using a systematic selection method based on different asset classes (equities, fixed income and commodities). The exposure to the portfolio will however be adapted in order to keep the Sub-fund annual volatility at a target level of 5%.

#### Investment strategy

 The investment strategy takes long and limited short positions resulting in a net long position in each asset class (equities, fixed income, commodities and real estate).


- The allocation within the strategy is determined by using an optimization model, that aims to maximize the portfolio's expected return while controlling its volatility.


- The optimization model is carried out every day on the investment universe.

- It benefits from a systematic risk control mechanism which aims at keeping its annual volatility at a target level of 5%.



## Risks

Risk of capital loss: The investments in the funds are subject to market fluctuations and the risks inherent in investments in securities. Risk related to the use of forward financial instruments: In order to achieve its investment objective, the Sub-Fund makes use of forward financial instruments traded over-the-counter that allow it to replicate the performance of the strategy. These instruments may involve a series of risks that could lead to adjustments or even the early termination of the instrument, which may affect the Sub-Fund's NAV.

#### Glossary

Morningstar category EUR Flexible Allocation: EUR Flexible Allocation funds have a largely unconstrained mandate to invest in a range of asset types for a EUR-based investor.

Net Asset Value - Represents the net assets of the fund (ex-dividend) divided by the total number of shares issued by the fund.

Historical tracking error - Measure of the actual deviation of the fund's returns from the comparative benchmark index returns (annualised). A higher number means that the fund is taking greater risk against the benchmark. Historical Volatility of Portfolio - Illustrates the dispersion of the fund's realized monthly returns around the average monthly return, indicating how volatile the fund's return is over time. The higher the number the more volatile the fund's returns.

UCITS - "UCITS" or "undertakings for the collective investment in transferable securities" are investment funds regulated at European Union level. They account for around 75% of all collective investments by small investors in Europe. The legislative instrument covering these funds is Directive 2014/91/EU.

Ongoing Charges - The ongoing charges figure is based on the fund's expenses during the previous year. It excludes transaction costs and performance fees incurred by the fund
