
#### Investment strategy


- Every month, the Strategy selects equities on the basis of fundamental and market criteria.



### Risks

Liquidity risk - This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.

### Glossary

UCITS V - "UCITS" or "Undertakings for the collective investment in transferable securities" are investment funds regulated at European Union level.
