The objective of Quaero Capital Funds (Lux) – Cullen ESG US Value is to seek long-term capital appreciation through responsible investments in equities of US companies across all market capitalizations, trading at valuation levels deemed attractive by the Sub-Investment Manager. The Fund invests in companies which are industry-leading on environmental and social responsibility and stewardship, or are on a path of committed improvement, provided that they follow good governance practices. The investment approach is active, bottom-up and driven by fundamental research. The Fund is categorized as a SFDR Article 8 Product.






SECTORAL BREAKDOWN


