

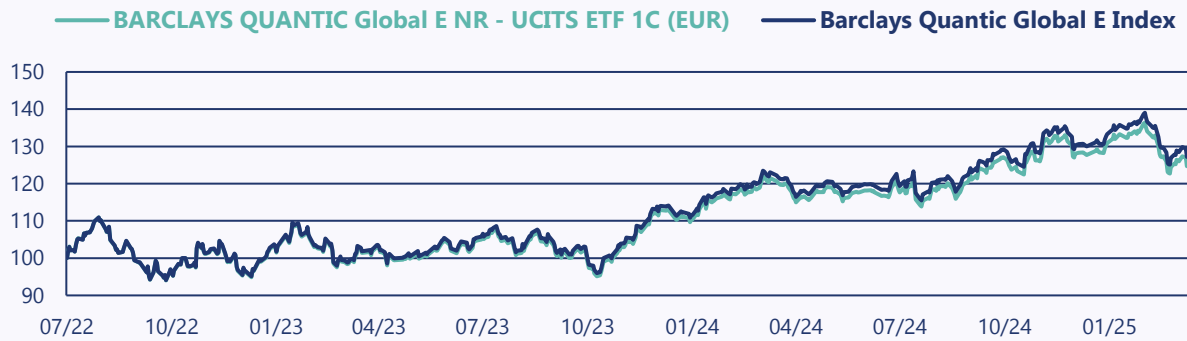

STRATEGY DESCRIPTION

The investment objective of the Barclays Quantic Global E NR (the "Fund") is to replicate, before deduction of the Fund's fees and expenses, the performance of the Barclays Quantic Global E Index (the "Index"), expressed in EUR. The Index is a Barclays index designed jointly with Quantic Financial Solutions GmbH and calculated by Solactive AG. The Index invests in global developed market equities, selected on the basis of the highest fundamental scores provided by Quantic and their environmental risk rating provided by Sustainalytics.

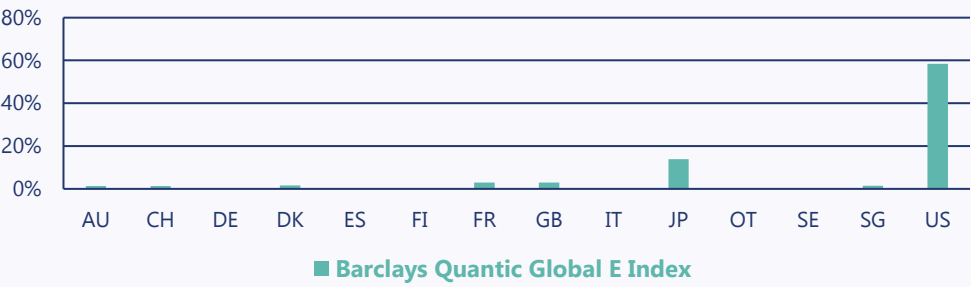

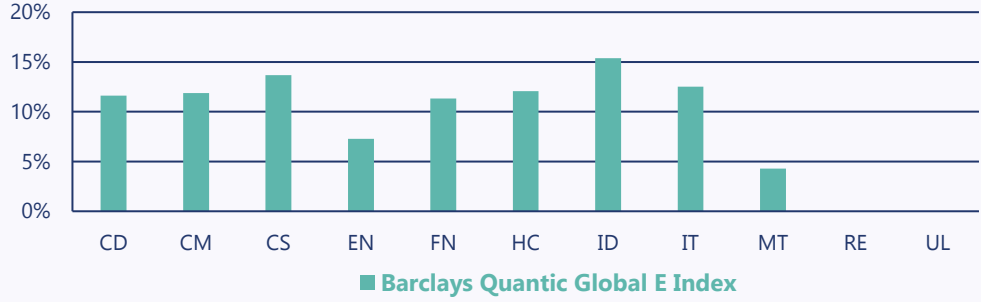
GEOGRAPHIC ALLOCATION

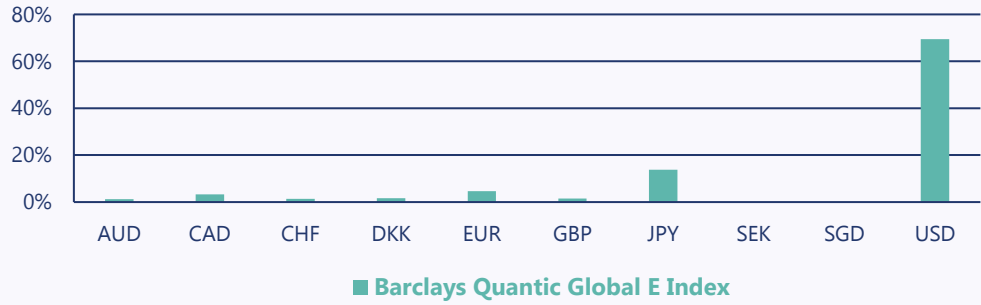
SECTOR ALLOCATION
