## FUND AIM

The objective of the Fund is to provide long term capital growth and income. The Fund is actively managed and seeks to achieve this objective by investing in a broad range of US Dollar denominated securitised assets. The Fund will invest at least 80% of its net assets in US Dollar denominated fixed income securities, with a diversified allocation to investment grade rated instruments with short duration.

## WHO IS THIS FUND FOR?

- This Fund is designed for investors looking for income or growth from an investment in fixed income securities
- Although investors can take their money out at any time, this fund may not be appropriate for those who plan to withdraw their money within five years
- This fund is not designed for investors who cannot afford more than a minimal loss of their investment

## FUND SNAPSHOT

- **What does it invest in?** Invests predominately in US Dollar denominated fixed income securities, including Asset Backed Securities (ABS), Mortgage Backed Securities (MBS), Collateralised Loan Obligations (CLOs) and Asset Backed Commercial Paper (ABCP). The fund may also invest in Government and Government related bonds
- **How does it invest?** Actively managed, investing in a portfolio of fixed income securities. The fund will make use of derivatives for investment purposes and/or for efficient portfolio management.
- **Does it promote sustainability characteristics?** The fund promotes a range of environmental and social characteristics. Further information on how such characteristics are met by the Fund can be found in the Supplement.

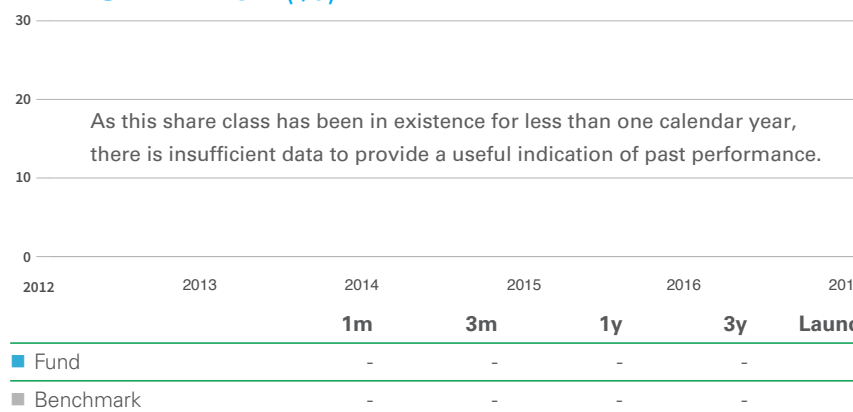

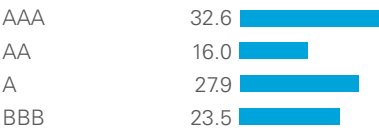
PORTFOLIO BREAKDOWN

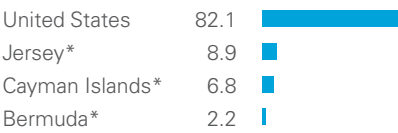
CURRENCY (%)



CREDIT RATING (%)

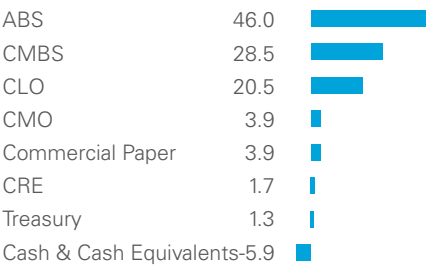


COUNTRY (PV %)



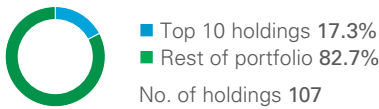

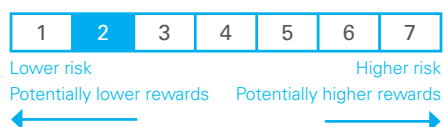

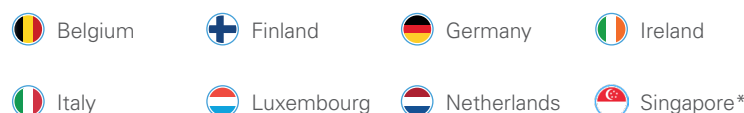


## KEY RISKS
